The fund's objective is to provide investors with liquidity while providing reasonable returns by investing its assets in deposits.

THE FUND IS SUITABLE FOR INVESTORS WHO:

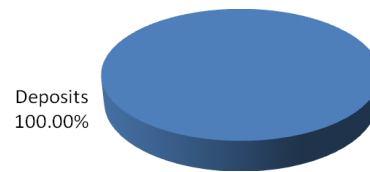
- Require liquidity;
- Seek reasonable returns that commensurate with the low risk's investment; and
- Prefer a short-term investment horizon.

ASSET ALLOCATION

The fund's portfolio will be structured as follows:

- 90% to 100% of Net Asset Value (NAV)
Investments in deposits placed with financial institutions which have a remaining maturity period of not more than 365 days.
- Up to 10% of NAV
Investments in deposits placed with financial institutions which have a remaining maturity period of more than 365 days but fewer than 732 days.

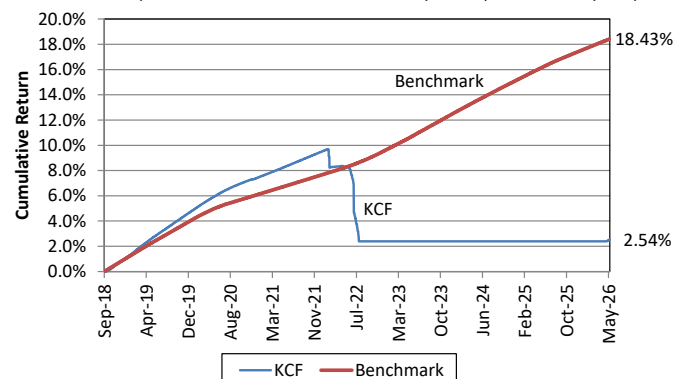

Based on the Malaysian Fund Volatility Report issued by Refinitiv Lipper dated 10 June 2026, the Volatility Factor (VF) for this fund is 0.08 and is classified as "Very Low". "Very Low" includes funds with VF that are between 0 and 4.705. The VF means there is a possibility for the fund in generating an upside return or downside return around this VF. The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified funds. VF is subject to monthly revision and VC will be revised every six months.
